Financial transaction tax on acquisitions of shares of companies: <ul style="list-style-type: none"> <li>with a registered office in Spain</li> <li>with a market cap &gt; 1 billion EUR on 1<sup>st</sup> of December of the year preceding the acquisition</li> <li>listed on the Spanish or foreign regulated stock exchange</li> </ul>	0,20%
